# Our aims and purposes as a charity

The PCC has the responsibility of co-operating with the incumbent, the Reverend James Grant, in:

- The promotion of the gospel of the Lord Jesus Christ according to the doctrines and practices of the Church of England;
- Promoting in the parish the whole mission of the church, pastoral, social, evangelistic and ecumenical;
- Knowing Jesus better and making Him better known;
- Practical support and care for people in the parish, from the youngest to the eldest, irrespective of level of need or ability to pay;
- Providing financial support to those in need and to other organisations with similar objectives.

# What we planned to do to achieve our charitable objectives

During 2023 our aim has been to continue normal services and encourage attendance to more community activities

When planning our activities for the year, our incumbent and the PCC have considered the Charity Commission's guidance on public benefit and, in particular, the specific guidance on 'charities for the advancement of religion'.

The council has complied with the duty under section 5 of the Safeguarding and Clergy Discipline Measure 2016, fully recognising its duty to have due regard to the House of Bishops' guidance on safeguarding children and vulnerable adults.

During the year we discussed and planned the following objectives and activities to fulfil our aims:

- Enabling as many people as possible to worship at our church
- Enabling as many people as possible to become part of our parish community
- Teaching, baptising and nurturing new and existing believers
- Maintaining an overview of worship throughout the parish
- Considering how services can involve the many groups that live within the parish
- Putting faith into practice, through prayer and scripture, music and sacrament
- Offering worship and prayer, learning about the Gospel, in small group situations
- Holding courses to advance religion and e-learning educational courses, such as safeguarding
- Assisting people from all walks of life to develop their knowledge of, and trust in, Jesus
- Provision of pastoral care for people living in the parish
- Reaching out to the unchurched through provision of Coffee Mornings and other events such as concerts and presentations
- Maintaining the fabric of the church building as a historic centre and focus of life in the village.

# What we achieved and how we affected beneficiaries' lives

#### Attendance at worship

We welcome all worshipers whether from within or outside the parish boundary. Visitors attend by personal choice and it is our great pleasure to welcome anyone from all walks of life to take part in the life of the church. We contend that voluntary attendance to worship the Lord Jesus Christ is a major demonstration of the public benefit of our activities.

The average regular weekly attendance, was 37 adults and 2 children.

We look to encourage the deepening of faith for all ages alongside our services. Christmas is always a very special time of celebration where many sections of the community come together to join in the services. These include the Candlelit Nine Lessons and Carols, Crib Service and Midnight Mass. It was a joy to see an increased attendance to all three services

We continued our emphasis upon the family and the children's ministry. However there is still a sad lack of attendance by families. On the first Sunday of every month Sung Evening Prayer is held in the Church. There is a said Eucharist every Sunday with the 2<sup>nd</sup> Sunday being based upon the Book of Common Prayer. On the 3<sup>rd</sup> Sunday of the month the main Eucharist is traditional language. Said Eucharist has continued to be held on a Wednesday evening.

It has been lovely to have the choir each week to encourage our hymn singing.

On Easter Sunday an outside Easter egg hunt was again organised for the children. This always proves popular and enjoyable.

All Souls Service continues to offer comfort to a great many people

Christmas was, as usual, a very special time of celebration. The Nine Lessons & Carols service was well attended and we were once again able to follow the service with mulled wine and mince pies enabling the choir and attendees to mix and chat. On Christmas Eve, a very novel nativity crib service was held and Midnight mass was celebrated in a beautifully decorated and candlelit church, both services being well attended.

#### Mission

We have continued to hold the Mission Plan 'Benefice Vision 2022' set at the APCM in 2019

This year we continued with our new Mission Plan together with our partners in the United Benefice, the Parish of Kingston Buci. We gave ourselves a new vision statement "God calls us to be a community of faith, hope, and love".

## Teaching, baptising and nurturing new and existing believers

One wedding ceremony was held in the church.

It was with great delight that we celebrated the baptism of 3 children into the church.

Three funerals were conducted in church and five funerals conducted elsewhere.

There have been six interment of ashes

#### Evangelism and outreach

The monthly coffee mornings, organised by Helen Harvey and her team, have grown more popular and raised £3,841, with a total of £804 over 3 coffee mornings being sent to the charities: Children's Society, Family Support and Macmillan Nurses It has been a joy to welcome many more new faces from Shoreham who now put the monthly date in their diaries.

The Shoreham Chamber Choir has also held two concerts in the church. We once again held our Patronal Festival Quiz Night at St Nicolas and St Mary's School and had 74 attendees who also enjoyed a fish and chip supper. This raised in excess of £400 for the Friends of St Nicolas.

Church Newsletters have been delivered to those who do not have email. Telephone contact has been made to those who have been unwell.

# Provision of the church building for people to enjoy

Our church continues to be appreciated by our parishioners and many others as a space where life events are celebrated with joy and thanksgiving.

- \* The Coronation "Volunteers Day" encouraged local people to come and help tidy and weed the churchyard resulting in one family "adopting" the maintenance of a grave.
- \* Following the restoration of our Weather Vane, we held a special service to bless it. Later in September, the local Gilder gave a very enthusiastic and informative talk in the church about his craft.
- \* A local Goldsmith also gave up his time to describe and demonstrate the creative work he does.
- \* Two of our parishioners: John & Jeanette Simpson, together with several volunteers, gave a well-received presentation to a U3A Group from Horsham.
- \* The British Archaeological Association brought over a 100 people to visit the church in September.
- \* The church provided a peaceful environment for a small group of young men to meet and play games together, as one of the them had been ill and needed a quiet environment.

It is important to us that the church is available for private prayer, not just to the church family, but also to the wider visiting community. To this end the church is always open daily, not simply for the enjoyment of visitors to an ancient and architecturally important building, but to allow space for private reflection and prayer. Our Visitors' Book is full of tributes to the sense of peace and spiritual comfort people find here and of their gratitude for the church being open.

Their quotes collaborate this:

- \*Such a peaceful place. I feel very safe here. I was in turmoil but I now feel much calmer.
- \*A Beautiful, quiet place to sit today remembering the people of Ukraine on the anniversary of the start of the war and hoping for peace soon. Thank you for being open.
- \*So peaceful love sitting here with my thoughts. The perfect church.

## Provision of pastoral care for people living in the parish

The Pastoral Care Team, led by Father James, is responsible for hospital visits and home communion. The team also visits 3 care homes locally, with Carol Singing at Christmas time.

#### Provision of tangible support to the poor and needy

This year our harvest collection was for Adur and Shoreham Food Bank. The congregation have continued their generous support of the Adur and Shoreham Food Bank throughout the year. At our December Coffee morning we held a raffle in aid of the food bank, which together with the sale of homemade Christmas ornaments, raised £172.

# Other charitable giving

The weekly parish newsletter continues to be distributed to all who have requested it by email and by being available in the Church, free of charge. This helps to maintain links between the church family and those who have not yet felt the need to take part in what we do.

During Lent we had a collection jar for Water Aid. In May money was raised for Christian Aid in church and on line instead of the usual street collection. At Christmas the congregation was asked to donate to Christian Aid instead of giving Christmas Cards to each other and this raised an additional £200. Throughout the year we have also raised funds for the The Children's Society, Family Support Work and the Macmillan Nurses.

# Financial Review – supplied by Treasurer Gillian Powell

Without the very generous legacy left to St Nicolas, the church running costs for the year would have exceeded our income by £1553.99. Without increases in weekly and monthly giving this deficit will continue in the future and we will need to use the legacy funds to bridge that gap. We are very grateful to Cliff Emberlin for reclaiming gift aid. The contactless donation box has seen increasing use, providing very useful income, as has the donation box.

We now need to register with the Charirty Commission.

Energy costs remain high as the heating is kept on to provide an internal temperature of 16°C. This is important to keep the fabric of the church in good order.

A small part of the legacy was spent on repairing and restoring the weather vane in remembrance of John Nobbs, who had been a much valued member of the congregation.

## Sharing the ministry costs of the Diocese of Chichester

The largest expenditure of the PCC was the sum of £18,600 paid to the diocese towards our share of all churches' Parish Ministry Costs. This amount covers the housing, stipend and pension costs of the clergy, and also a standard sum for diocesan central costs, clergy training and a contribution to national church funds.

The PCC shares clergy expenses with Kingston Buci and supported the clergy by paying towards the Council Tax and towards Water and environmental charges for the Vicarage.

St Nicolas refunded the expenses of Reverend James Grant, as a trustee, towards other annual costs for travel, telephone, postage and broadband.

Staff costs: The PCC pays for an organist and a pianist. Further details are provided in the notes to the accounts.

There were no payments to persons related to or connected to the trustees.

# Independent Examiner's Report to the PCC of St Nicolas' Church, Old Shoreham for the Year Ended 31st December, 2023

This is my report to the Parochial Church Council of the Ecclesiastical Parish (PCC) of St Nicolas, Old Shoreham, on the financial report for the year ended 31st December 2023 set out on pages 1 to 5

#### Respective responsibilities of trustees and examiner

The PCC members are responsible for the preparation of the annual reports. The PCC members consider that an audit is not required for this year under section 144 of the Charities Act 2011 ("the Charities Act") and that an independent examination is needed.

It is my responsibility to:

- 1 examine the accounts under section 145 of the Charities Act,
- to follow the procedures laid down in the general Directions given by the Charity
- Commission (under section 145(5)(b) of the Charities Act, and
- 3 to state whether particular matters have come to my attention.

#### Basis of independent examiner's statement

My examination was carried out in accordance with general Directions given by the Charity Commission. An examination includes a review of the accounting records kept by the charity and a comparison of the accounts presented with those records. It also includes consideration of any unusual items or disclosures in the accounts, and seeking explanations from the trustees concerning any such matters.
